Sakaw must abide by conditions officers add to this permit, the "Temporary Work Camp Standard of November 14, 2022", section 17 of <i>The Wildfire Act</i>, and section 5 of the Wildfire Regulations when it comes to burning at camps. 4. All fires must be contained to burning barrels and only wood and paper products are permitted to be burned. All conditions set forward in the Sakaw 2025-2026 operating plan and approvals apply to this permit 5. Any environmental code chapter or provincial standards developed during the timeframe of this permit take precedent over other conditions unless otherwise legislated. | |
