Opportunity to Review Draft Forest Operating Plans

Sakaw Askiy is preparing the Forest Operating Plan for the Prince Albert Timber Supply Area (PATSA) for the next 5-year period. The Operating Plan focuses on the first year (April 1, 2027 to March 31, 2028) of harvesting and road construction in detail. Plans for Years 2-5 are outlined more generally. The plan is in draft form, and there is an opportunity to provide feedback before it is submitted. **Forest fires during spring/summer 2025 have had a vast impact (Planning, Operations, Renewal) on the PATSA - information is available to discuss those impacts.

Draft maps for Year 1 of the plan will be posted online after September 21, 2026. You will be able to click on the link in the “What’s New” section of the Sakaw website (www.sakaw.ca) and review the draft maps to see if harvesting is planned in an area of interest to you. If you wish to discuss the draft plans, please email admin@sakaw.ca as soon as possible, and include:

- the name of the map or the area you would like to discuss
- weekdays and times you are available; contact information where you can be reached.

The appropriate planner will then get in touch to arrange a discussion with you, through:

- a one-on-one phone call or online meeting (for viewing a map together),
- an online meeting with a small group, or
- a field visit.

The above methods of providing input work well. You can review the maps in your own time and have a targeted discussion with the appropriate planner or Sakaw when it is mutually convenient. Information sessions on the draft forest plans will also be held, featuring an opportunity to discuss the plans/maps with Planners in an open house format. The Forest Operating Plan will be submitted to the Forest Service on or before November 30, 2026 for review, along with records of the discussions held. Consultation with Indigenous communities is initiated by the Forest Service upon receipt of the plan. The approved plan and an interactive webmap will be available from the Home Page of Sakaw's website (sakaw.ca) in late April of 2027.

It is important to know that the webmap will show 2.5 times the area that will actually be harvested in Year 1 because contingency areas are included. Also, there is ongoing engagement with other land users throughout the year, even after Year 1 areas have been approved.

Opportunity to Discuss the Long-term Forest Management Plan

There is also an opportunity to discuss the 20-year Forest Management Plan for the entire landscape. The Forest Management Plan (FMP) provides strategic direction for managing the forests in the Prince Albert Timber Supply Area, for the 20-year period from April 1, 2018 to March 31, 2038. It includes a calculation of the available timber supply and outlines strategies for balancing the use of crown forest lands for economic, social, and cultural benefits, while protecting the long term health of forest ecosystems. As examples: the strategies include maintaining biological diversity (including species at risk, such as boreal woodland caribou), meeting standards for protecting soil and water, and taking non-timber uses into account. In short, the FMP provides the direction for how this forest area will be managed. It also drives what happens on the ground in the Operating Plans.

The FMP is available from the Home Page of Sakaw's website, www.sakaw.ca, by clicking on the 'Forest Management Plan' link. That link leads to a Saskatchewan Government website, <https://publications.saskatchewan.ca/#/categories/170>, where key documents related to the FMP and FMP amendments can be found. These key documents include annual reports on performance against the forest management strategies and targets set out in the FMP. This regular reporting is allowing Sakaw, the provincial government and the public to assess how the FMP is being implemented and whether expected outcomes for the forest landscape are being achieved.
